

SUMMARY ANNUAL REPORT

For INOVALON, INC. EMPLOYEE BENEFIT PLAN

This is a summary of the annual report of the INOVALON, INC. EMPLOYEE BENEFIT PLAN, EIN 71-1017974, Plan No. 510, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INOVALON, INC. has committed itself to pay certain self-insured Medical and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with VISION SERVICE PLAN, PRUDENTIAL INSURANCE COMPANY OF AMERICA, DELTA DENTAL OF PENNSYLVANIA, and JANUS ASSOCIATES, INC. DBS BHS to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$2,501,626.
